

# The GM Care Record

## 5<sup>th</sup> June 2020: Weekly Stakeholder Brief

### Latest Status of the GM Care Record



Work continues daily to add data feeds into the GM Care Record. The record now includes:

**Primary Care:** 99% of GP patient data across all GPs is now available for sharing.

**Acute Trusts:** 100% of Acute Trusts have removed their filters and are able to share their data with the GM Care Record. 80% have enabled their Single Sign On (SSO), with Pennine Acute looking to complete w/c 15<sup>th</sup> June, and WWL NHSFT confirming their dates.

**Mental Health:** All Mental Health organisations have removed their filters allowing full data sharing and have enabled SSO.

**Community:** 6 out of 7 community organisations have enabled SSO with the remaining one, WWL NHSFT, to confirm completion dates.

**Oldham Hospice:** have enabled their SSO to allow data sharing.

**Local Authorities:** 3 out of 10 local authorities have enabled their social care staff to access the record via SSO, as have 4 out of 6 'Out of Hours' sites.

Work to complete remaining secondary organisation feeds, such as clinical docs and A&E information, has commenced. As of today, **28** data feeds are outstanding, from a total of 70, with the remainder to be added to the record later this summer.

### Communications Update



Staff and public communications are now live on the GM Care Record with a [media release published](#) and a full communications plan being rolled out.

### Greater Manchester shared care record deployed across the whole region



Health and care organisations across Greater Manchester have accelerated the deployment of the GM Care Record for all 2.8million people.

## Secondary Uses Oversight and Scrutiny Group



The Oversight Group met to discuss the process by which individuals can request access to datasets in the GM Care Record, via the GM Care Record Population Health Analytics Platform, for specific **Covid-19 research projects**. The process will differ depending on whether access is requested for data from a locality or GM-wide, and whether it is for anonymised or pseudonymised data.

Legal, technical and ethical matters were discussed among the group of clinical, patient, digital and IG representatives. The group requested that a test use case be brought to the next meeting for discussion to improve their understanding of the process, with the aim of it then being agreed. No access will be granted before this process, and nominated delegated authorities, are in place.

## Clinical Reference Group (CRG)



CRG met to discuss the **minimum data specification for social care fields**. The agreement of a GM-wide minimum data specification will be a positive step towards standardisation - resulting in users being able to expect the same fields to be complete, no matter which organisation in GM the data has come from. The focus this week was around the Adult fields, with the aim to finalise the minimum data spec for both Adults and Children's Social Care next week.

A recommendations paper following the previous week's discussion on GM Care Record **specified access for care homes** will be submitted to GM Health and Social Care Covid-19 Digital Coordination Group next week.
